3107 people have visited the center so far this month. 19294 have visited in the past 6 ½ months. 1221 current members is a 23 ½ % increase in membership in the last six months. The Center has added 233 new members since the opening.

The Center has received a grant for programs which will be administered by Friends. The grant will allow the Center to provide additional programming in the New Year.

85 have signed up for the Thanksgiving Luncheon and Entertainment, Friday the 21st at 12 pm. Each year the Center provides food or gift cards for Seniors in Need. The seniors are selected in conjunction with information provided by social services and the list is usually 20-25 recipients. Mary Stone put forth a motion to give Stephanie funds for the Seniors In Need, the amount to be discussed. The board agreed on \$1000. Mary Stone adjusted the motion to reflect the amount of \$1000, Margaret Thach seconded. Motion carried. The Center will also ask the community to participate in support of the Seniors in Need by donating gift cards for a local grocery store(s). The December Food Drive will benefit the Senior Center Food Pantry. A collection box will be placed near the senior center check- in and a suggested list of items will be provided.
